#### **Archery Hunt: October 1, 2, 7, 8, 9, 14, 15, 16, 21, 22, 23**

15 permits will be drawn on Sept. 12, failure to purchase permit by Sept 22nd will result in forfeiture. Cancellation after Sept. 30th will result in loss of any paid fee.

#### **Archery Spike, Antlerless & Turkey (either sex): October 28, 29, 30**

10 permits will be drawn on Sept. 12, failure to purchase permit by Oct. 7th will result in forfeiture. Cancellation after Oct 14th will result in loss of any paid fee.

#### **White tail Buck: November 11, 12, 13**

4 Permits will be drawn on Oct. 17th, failure to purchase permit by Oct. 28th will result in forfeiture. Cancellation after Nov. 4th will result in loss of any paid fee.

#### **White tail Doe: November 18, 19, 20**

Up to 10 permits will be drawn on Oct. 17th, failure to purchase permit by Oct. 28th will result in forfeiture. Cancellation after Nov. 4th will result in loss of any paid fee.

#### **Mule Deer Buck: December 2, 3, 4**

4 permits will be drawn on Oct. 17th, failure to purchase permit by Nov 11th will result in forfeiture. Cancellation after Nov 23rd will result in loss of any paid fee.

### **All hunters must provide a Hunter Liability Release Form, hunting application, copies of 11-12 hunting license with appropriate stamps and driver's license to purchase a permit.**

*Purchase of a Permit does not guarantee the harvest of game. Hunters may be assigned a specific area in which to hunt; some assigned areas require use of a 4-wheel drive vehicle for access.*
